## Notice Regarding Open House Matching for Foreign Candidates

## (MECEE-PG 2025)

This is to inform the concerned candidates that the open house matching for Foreign Subcategory I (Foreign to appear) and Foreign Sub-category II (Foreign NOT to appear) of MECEE-PG 2025 program will be conducted as follows.

A. Matching Schedule for Foreign Sub-category I (Foreign to appear MECEE-PG 2025) The schedule for the open house matching session for foreign merit candidates who took part in the entrance examination for the Postgraduate Level Program (MECEE-PG 2025) is given below.

- a) Venue for open house matching will be Medical Education Commission, Sanothimi, Bhaktapur, Nepal
- b) The information regarding available foreign seats has already been published on the MEC website (www.mec.gov.np).
- c) The successful candidates, as per the merit list published must be present physically with the following original documents.
  - Exam admit card and score card,
  - Passport/Aadhaar card/Print copy of E-Aadhar card,
  - Professional council registration certificate of respective country,
  - Transcript and certificates of relevant bachelor's degree or equivalent.
- d) Candidates will be verified by the Biometrics taken during the entrance examination, and the same will be sent to respective colleges.

- e) No candidate will be allowed to enter the hall after the open house matching session begins.
- f) The matched candidates are required to take admission in the respective University/ Academy (NOT directly to the college).
- g) It is also notified that the respective Universities/Academies will hold the original certificate of matched foreign candidates until they are enrolled in the respective institutions.
- h) Candidates who submit fake documents will be rusticated during matching or even after admission and s/he will be liable for legal actions as per the prevailing rule and regulation of Nepal.

## B. Matching Schedule for Foreign Sub-category II (Foreign NOT to appear MECEE-BL 2025)

The open house matching for foreign candidates who had duly applied under Foreign Subcategory II (foreign NOT to appear MECEE-PG 2025) will have to appear for the remaining foreign seats based on the score obtained in the national level common entrance examination of their respective country.
